USER'S RENTAL AGREEMENT: I assume full responsibility for the USAG-DTA-MWR Outdoor Recreation Rental Department equipment listed below and the parts and accessories to said equipment; and upon request agree to pay for damages incurred to said equipment and accessories excessive of normal use and depreciation. As assessed by the Outdoor Recreation department staff. I also accept total liability for all damages or injuries incurred through assembly, sue or misuse of the equipment and accessories listed in this contract. I agree to assume all risks and responsibility for any and all claims for damages and for injuries suffered while equipment, and to hold the DTA-MWR Outdoor Recreation Division, the staff and the U.S. Army harmless and not responsible for injury or accident incurred while using this equipment.

LATE/DAMAGE/LOST EQUIPMENT POLICY: I understand that I am responsible for returning this equipment with all parts and accessories on the date indicated below. I also understand that there will be a late fee charged a the rate of 1 1/2 times the rental fee, per item, per day until the equipment is returned. Equipment must be returned clean, dry and in good condition. If necessary a cleaning fee starting at \$5.00 per equipment item will be assessed at the Recreation Rental Manager's desecration. Damaged or lost equipment will be assessed at the current retail replacement or repair cost. Charges made on lost or damaged equipment are non refundable and not contestable.

REFUND POLICY: The user must pay the total balance of the equipment rental upon reservation. The user may cancel a reservation for equipment up to 48 hours prior to checkout time or no rental fees paid will be refunded. No credit or refund will be issued for items rented but not used or for early return.
